How Does It Works?

The e-CPE Learning Program is delivered entirely through www.icpas.org.sg:8080/ksdlms/UserSignout.do. The course is self-contained. Students will also have access to an online course manager.

Students can enrol online through www.icpas.org.sg at any time during the year. Following payment by Internet Banking, they will have access to the online course for a period of 1 month, during which they will work through the course material and attempt the optional Multiple Choice Question (MCQ) test at the end of the course.

ICPAS members can claim 1.5 hour of verifiable continuing professional education (CPE) for successfully completing the program.

1. How do I register? For ICPAS Members

- a) Go to www.icpas.org.sg.
- b) Please log-in using the User Name and Password given by ICPAS.
- c) Once completed, please click on the 'E-learning Courses' icon on the right-hand side of the screen.
- d) Find the course which you are interested in and click on the 'Enrol Me' icon.
- e) You will be automatically re-directed to the payment page. Please follow the stated steps for payment using Internet Banking.
- f) Upon successful completion of the transaction payment, a e-CPE log-in name and password will be sent to your email account.

For Non-Members

- a) Go to www.icpas.org.sg.
- b) Please click on the 'E-learning Courses' icon on the right-hand side of the screen.
- c) Find the course which you are interested in and click on the 'Enrol Me' icon.
- d) Complete the registration form and click 'Submit'.
- e) You will be automatically re-directed to the payment page. Please follow the stated steps for payment using Internet Banking.
- g) Upon successful completion of the transaction payment, a e-CPE log-in name and password will be sent to your email account.

2. When can I register?

Students can enrol online at any time throughout the year – there are no closing dates.

3. How can I pay for the e-CPE program?

The current method of payment for the online courses is by Internet Banking for POSB/DBS, UOB and Citibank Account holders. (Please call 65325312 for alternative payment modes).

4. What is the duration of the course?

You will have access to the course for 1 month exactly from the date you are given the e-CPE User Name and Password via email.

5. How do I access the course once I have registered?

Upon successful completion of payment, a User ID and Password alongside instructions on how to access the course will be emailed to you. Please follow these carefully to access the course materials.
